The Club achieves this mission by offering a variety of after-school and summer programs focusing on Leadership and Service, Education, The Arts, Health and Wellness, and Sports and Recreation.

The Club is searching for individuals who are excited about implementing world class youth development programs. Applicants should also be earnest about providing for the safety of young people, staff, and volunteers. Our goal is to make sure success is within reach of every young person who enters the Club's doors, with all members on track to graduate from high school.
